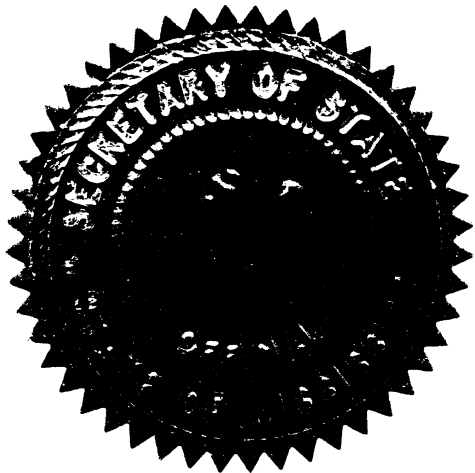


Certification of Vote for State Officers
