CONSTITUTIONAL AMENDMENTS

AMENDMENT NO. 1

SENATE CONCURRENT
RESOLUTION 522

This proposed amendment provides that after January 1, 2004, as vacancies occur, the twelve-member Board of Trustees of State Institutions of Higher Learning shall be appointed from each of the three Mississippi Supreme Court districts, until there are four members from each Supreme Court district. The terms of office are reduced from twelve years to nine years. The terms are staggered so that all members appointed after 2012 will have a term of nine years.

[T]he arrangement of the names of the candidates, and the order in which the titles of the various offices shall be printed, and the size, print and quality of paper of the official ballot is left to the discretion of the officer charged with printing the official ballot; but the arrangement need not be uniform...

It is the duty of the Secretary of State, with the approval of the Governor, to furnish the designated commissioner of each county a sample of the official ballot...the general form of which shall be followed as nearly as practicable.
