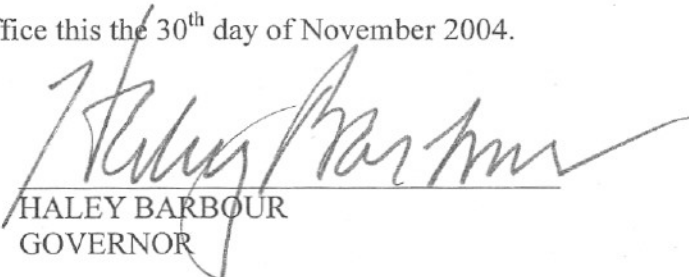


CERTIFICATION
