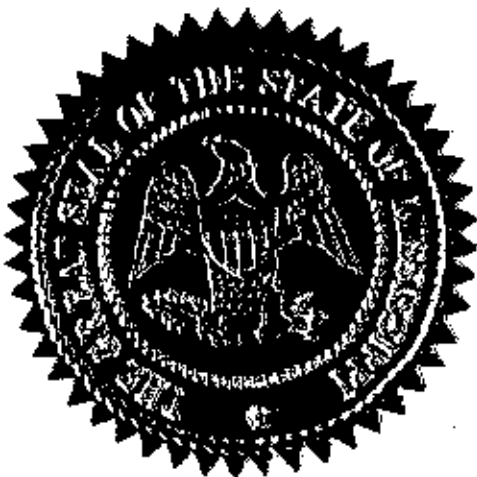


Certification of Vote
