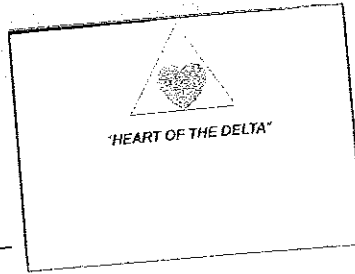

MONDAY, JUNE 17, 2013

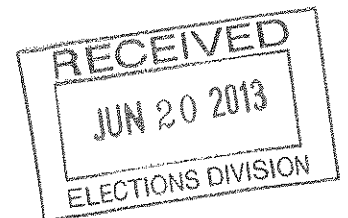
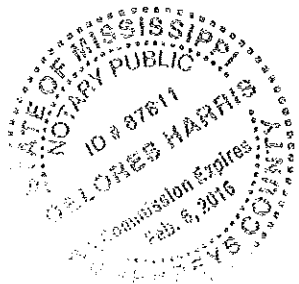
