

We, the Municipal Election Commission, met on the 8th day of May, 2013 for the purpose of examining the results of the Municipal Republican Primary, held on the 7th day of May 2013, for the offices of Mayor, the Board of Aldermen and the Municipal Republican Executive Committee, and made the following determination:


Having examined the results for the Office of Mayor, Billy D. Karolyi garnered sixty (60) votes, and having no other opposition, was declared the winner.


Upon examining the results for the Office of Board of Aldermen, of which six candidates qualified, David T. Aultman garnered sixty-four (64) votes, Freddy G. Bullock garnered sixty-five (65) votes, David R. Daniel garnered sixty-two (62) votes, Bobbie Jo Harrell garnered forty-five (45) votes, Richard B. Hux garnered thirty-five (35) votes, and Michael J. Wilcosky garnered sixty-one (61) votes. Because all Board positions are "At-Large" positions, the top five vote recipients, who are David T. Aultman, Freddy G. Bullock, David R. Daniel, Bobbie Jo Harrell and Michael J. Wilcosky, and having no other opposition, were declared the winners.


Also having examined the results for the Republican Municipal Executive Committee of which six candidates qualified, Michael B. Moore, Patricia J. Moore, Dawn M. Kelly, James A. Kelly, Steven O. Sanford and Tina S. Sanford, and having no other opposition, were declared the winners.

Because there were no other qualifiers, either Democrat or Independent, for Mayor or Board of Aldermen, we the Municipal Election Commission will dispense of the General Election on the 4th of June, 2013 as outlined in the Mississippi Code Annotated 23-15-361 (6) and declare, having met the qualifications to hold office, Billy D. Karolyi as Mayor and David T. Aultman, Freddy G. Bullock, David R. Daniel, Bobbie Jo Harrell and Michael J. Wilcosky as the Board of Aldermen.
