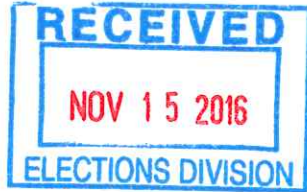


**Official Recapitulation




District 1 - Election Commissioner
