AMORY, MISSISSIPPI

12/16/2020

The Election Commissioners met Wednesday, December 16, 2020 at 10:00 a.m. in the office of the City Clerk in Amory's City Hall. The following person were present: Floyd Smith, Debbie Harris, and James Bost.  
Also present was City Clerk Jamie Morgan.

The Election Commission verified the receipt of the ballots (both used and unused) to be secured in a lockbox at the City of Amory City Hall.  
The Election Commission reviewed and verified the ballots including affidavit ballots received during the Special Election held December 8, 2020.  
See attached spreadsheet for breakdown of counted and non-counted ballots.  
These totals were added to the unofficial totals (from night of election) to determine an official total for the election.

One affidavit ballot was cast. The ballot was found to be invalid. Voter registered 11/30/2020. Cutoff for registration was 11/09/2020.

The results from the 12/08/2020 election were certified.

An election as to whether or not a Tourism Tax may be levied in Amory, MS upon every person, firm, or corporation operating a motel or hotel at a rate of 2% and every person, firm, or corporation operating a restaurant at rate of 2%. The measure must pass by a 60% vote.	Fail

City Clerk Jamie Morgan will send a certification copy to the Mississippi Secretary of State for their records.


With no further business, the meeting was adjourned.




