We, the undersigned, duly qualified Election Commissioners of the Municipality of Biloxi, Harrison County, Mississippi, duly and legally authorized by law to hold a special election in the Municipality of Biloxi, Mississippi on the question of granting a franchise to Mississippi Power Company for a period of twenty-five (25) years, do hereby certify that on Tuesday, the 4<sup>th</sup> day of AUGUST, 2020, being the day fixed by the City Council of said Municipality of Biloxi, Mississippi, said election was held by us in strict accordance with the law.
