There came on for consideration at a duly constituted meeting of the Mayor and Board of Alderman of the Town of Inverness, held on Tuesday, November 10th, 2020, the following order was passed:

AN ORDER BY THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF INVERNESS, PURSUANT TO MISS. CODE ANN. SEC. 23-15-857, AS AMENDED, TO APPOINT THOMAS GASTON HORNE, III TO FILL THE VACANT POSITION FOR ALDERMAN WARD TWO (2) AND FOR RELATED PURPOSES:

WHEREAS, on November 10th, 2020, the Mayor and Board of Aldermen adopted Resolution authorizing a Special Election to fill the vacancy for Alderman Ward Two (2), with the Special Election set for November 17th, 2020; and

WHEREAS, the qualifying deadline was Monday, October 19, 2020, only Thomas

Gaston Horne, III submitted a Qualifying Statement of Intent and Petition with the required signatures; and

WHEREAS, on October 20th, 2020, after reviewing the documents, the Municipal Election Commissioners accepted Thomas Gaston Horne, III, Qualifying Statement of Intent and Petition and declared him as the one (1) person duly qualified to be a candidate for the Special Election; and

WHEREAS, in accordance with Miss. Code Ann. Sec. 23-15-857, which provides in part, as follows:

if nineteen (19) days before the date of election only one (1) person shall have qualified as a candidate, the governing authority, shall dispense with the election and appoint that one (1) candidate in lieu of an elections

the Governing Authority desires to appoint Thomas Gaston Horne, III as Alderman of Ward Two (2)

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF INVERNESS, MISSISSIPPI, AS FOLLOWS:

- Section 1. That the matters, facts, and things recited in the Preamble to this Order be, and they are hereby adopted as the official findings of the Governing Authority.
- Section 2. That the Board of Aldermen hereby acknowledges and accept the findings of the Municipal Election Commissioners that only one candidate, Thomas Gaston Horne, III qualified for the Special Election of Alderman Ward Two (2) and therefore the Special Election is not necessary.
- Section 3. That Thomas Gaston Horne, III should be and hereby is appointed as Alderman Ward Two (2) and that the City Clerk shall be and hereby authorized to certify the appointment to the Secretary of State.
- Section 4. This order shall take full force and effect immediately upon its passage and enactment according to the law and shall be spread upon the minutes of the Town.
