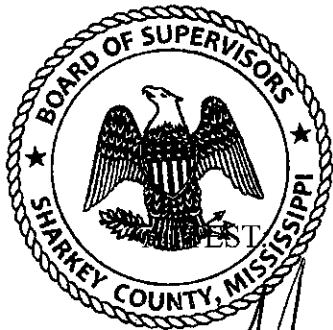
WILLIE SMITH moved to accept the report from the Yazoo Mississippi Delta Joint Water Management District.


