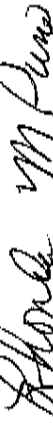

District 1 - Election Commissioner

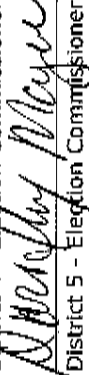


District 2 - Election Commissioner
