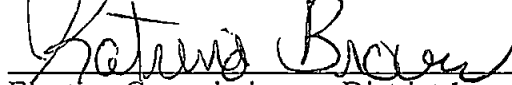


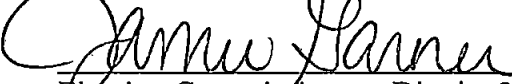
**Official Recapitulation**

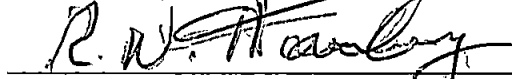

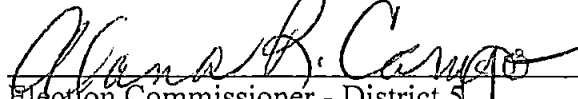
