
Dear Secretary Hosemann:





Whereas, following 2 additional recounts of ballots for alderman candidates Charlie Brister and Charolette "Cissy" Canova, both candidates received 125 votes each. Pursuant to conversation with Phil Carter with the Mississippi State Attorney General's Office, and Mississippi State Code Section 23-15-611, a tie must be broken by a drawing of lots. What constitutes a lot is determined by the candidates.

Upon consultation with Charlie Brister and Charolette "Cissy" Canova, they have agreed to decide the tie in the June 2, 2009 Municipal Alderman Election by drawing the highest number from 1 to 10.
